### I. Introduction

---

The City of Seattle Human Services Department (HSD) is pleased to issue its 2024 Notice of Funding Availability (NOFA) related to the following investments:

1. Older Adult Transportation Services
2. Kinship Caregiver Support Services
3. Respite Services
4. Gender-based Violence Prevention Services
5. Community Living Connections
6. Unhoused Street-Based Outreach
7. East and South King County Congregate Meals
8. ~~Community Safety~~
9. Afterschool Meals

This notice provides a revised overview of HSD's funding opportunities for 2024 with a brief description of the service areas for each opportunity, anticipated funding amounts, release dates, and contract start dates. Once finalized, HSD will issue detailed funding opportunities for each investment.

HSD invests in services that connect people with resources and solutions in times of need so we can all live, learn, work, and take part in strong, healthy communities. Guided by HSD's Theory of Change, funding opportunities will include both population level and racial disparity data and will outline the desired results of the investment. In 2024, HSD will include new questions focused on a) language access for people who are deaf or hard of hearing and b) program and service accessibility for individuals for whom English is a second language.

HSD emphasizes the importance of equity by engaging with communities who have been disproportionately impacted by systems of oppression and/or are underserved, such as communities of color, limited English speakers, LGBTQ, persons with disabilities, seniors, and low-income individuals and families. HSD recognizes reducing racial and social disparities may require organizations to collaborate and develop a shared strategy to serve our diverse population. HSD is particularly interested in partnerships that are co-designed and formalized through subcontract arrangements. Partnerships should reflect an equitable division of funding, a focus on strengthening the capacity of partners, a commitment to collecting and using data, and the leveraging of investments by other public or private organizations committed to the project. Any application outlining a partnership will require partner agency signature and may require a memorandum of understanding between agencies.

This notice also links to resources to help potential applicants learn more about HSD's investment priorities and standard application requirements. Each funding opportunity, when released, will provide additional detailed information specific to the funding opportunities in the table below.

In the event of budget additions through Mayoral or City Council budget appropriations, HSD may elect to modify existing contracts until such contracts require a new funding process, or HSD may develop a new funding opportunity to expend the additional funds. ### 2024 Older Adult Transportation Services

HSD intends to invest in community transportation services that allow older adults to access healthcare services and healthy food in the setting of their choice. These services are designed for participants who are unable to use King County's fixed-route public transit network.

### 2024 Kinship Caregiver Support Services

HSD intends to invest in services that support kinship caregivers age 55 and older who are caring for a family member's child. Participants are supported through the following services:

- Kinship Caregiver Support Program
- Kinship Navigator Program
- Kinship Collaboration Coordinator

### 2024 Respite Services

**Closed**

HSD intends to qualify organizations to provide respite care and/or housekeeping and errands, under the Family Caregiver Support Program. Respite care services provides short-term relief to unpaid primary caregivers of older adults. Respite care includes help with activities of daily living (ADL) e.g. dressing, eating, medication reminders, bathing, meal preparation.

These services are rate-based reimbursement for hours provided. Contract's will have no minimum award and no minimum numbers of referrals are expected to be maintained by the qualifying organizations.

## 2024 Gender-based Violence Prevention Services

**Closed**

HSD intends to invest in community led, culturally relevant Gender-Based Violence (GBV) primary prevention strategies and programming that stop Gender-Based Violence from happening. Gender -Based Violence is harm, or threats to harm, committed against a person(s) based on actual or perceived sex, gender, sexual orientation, gender identity or expression or other such sex/gender related characteristics.

**The 2024 Gender-Based Violence Prevention Services RFP will address racial inequities and intersections with sexism, homophobia, transphobia, ableism, and other forms of oppression that are causative factors for Gender-based Violence to reach the most vulnerable, at-risk members of our community.**

## 2024 Community Living Connections

**Closed**

HSD intends to invest in a “no wrong door system” to connect people with programs and services. Eligible participants include older adults (age 60+), adults with disabilities (18+) and unpaid caregivers (18+) living in King County. Participants are supported through a continuum of services including:

- Information, Assistance, and Outreach
- Regional Coordination
- Care Coordination
- TCARE® Assessment and Care Planning
- Respite and Emergency Respite Coordination
- Caregiver Counseling, Support Groups, Training and Consultation

## 2024 Unhoused Street-Based Outreach

**Closed**

HSD intends to invest in specialized outreach services for individuals living unhoused to navigate, access, and enter shelter and stable housing, as well as receive other needed assistance, to meet each individual’s unique needs.

The City is seeking qualified providers to conduct four specific outreach types:

- Neighborhood-specific care coordination services to facilitate temporary or permanent housing access
- Neighborhood-specific care coordination outreach to people living in vehicles
- Neighborhood-specific outreach to those with severe mental health, behavioral health, and co-occurring disorders
- Citywide outreach to assist individuals in a culturally- or population-specific manner

## 2024 East and South King County Congregate Meals

**Closed**

HSD intends to invest in Congregate Meals for Older Adults at Senior and Community Centers in East and South King County. This is a re-procurement of a portion of the 2023 Congregate Meals for Older Adults RFQ.

The City is seeking qualified meal providers to provide meals in partnership with the following meal sites: Auburn Senior Activity Center; Black Diamond Community Center; Des Moines Activity Center; Enumclaw Senior Activity Center; Federal Way Community Center; Issaquah Senior Center; North Bellevue Community Center; Pacific Community Center; Peter Kirk Community Center; Redmond Senior and Community Center; SeaTac Community Center; Tukwila Community Center. Only one meal provider will be selected for each meal site; providers are encouraged to apply to serve meals at multiple sites.

Awarded agencies will be expected to incorporate supportive and trauma-informed intervention services in their program models for individuals (12-30 years of age) and their families.~~

~~Agencies will also be required to share resources, coordinate ways to meet the needs of participants, and build stronger interagency collaboration through a Community Safety Network facilitated by HSD.~~

## 2024 Afterschool Meals

HSD intends to fund a maximum of one contract to prepare and deliver fresh meals to 3-10 sites with a minimum of 20 children per site, a total of an estimated 3,000 meals per contract period. Meals will be prepared and delivered the 2024 – 2025 school year.
